

# OOPS Activity Planning Worksheet

<b>Title:</b> Aldrich Point and Nearby Islands		<b>Type of Activity:</b> Trip	<b>Date(s):</b> 04-12-2009
<p><b>Narrative description:</b> We'll put in at Aldrich Point on the Oregon side of the Columbia, catching the tail end of the ebb as we travel west through Prairie Channel. Our exact route will be determined by participant interest and paddling conditions, but the general plan is to travel through and around the nearby islands, such as Horseshoe, Marsh, Woody, and Tronson, taking advantage of the current. With the waterfowl hunting season over, we should have have freer reign of the islands than we do during winter.</p> <p>By about lunchtime, the ebb will have slowed significantly, allowing us to turn back upriver. The remainder of the paddle will be with slack or flood conditions, permitting us to make our way back to Aldrich Point by a route of our choosing.</p> <p>Although the plan is to remain largely in and near the islands, we may paddle in the main channel, and we could cross the main channel in the direction of Pillar Rock or Jim Crow Point, for example, if that's the concensus desire of the group and if conditions permit. Consequently, participants should be both comfortable with and able to paddle in Level III conditions, including moderate wind, whitecaps, chop, and--potentially--some occasionally breaking waves. Likewise, although we don't intend to paddle at an exceptionally fast pace, the timing of the current could require us to make good time for portions of the trip. Nonetheless, we plan to find time for photography and other play, if the group so desires. Likely distance traveled will be 10-12 statute miles. Wetsuit or drysuit is required, as is a flashlight, in case we're unexpectedly delayed. Tow rig and VHF radio recommended.</p> <p>If one or more additional organziers sign up, we could accept more participants. If you have any questions about the plan or any of its requirements, please contact the organizer.</p>
